The significant increase in the profit for the year ended 31 March 2010 was mainly attributable to the net effect of an increase in the share of profit of an associate, a gain on deconsolidation of M8 Entertainment Inc. and its subsidiaries (the "M8 Group"), a decrease in the gain on the change in fair value of conversion option derivative and a decrease in the deferred tax credit as compared to the financial year ended 31 March 2009.

However, with respect to the unaudited financial results of the Group for the three months ended 31 March 2010, it is expected that there would be a decrease in the unaudited profit of the Group as compared to the unaudited financial results of the Group for the three months ended 31 December 2009. It was mainly due to the net effect of a decrease in the share of profit of the associate, a loss on the change in fair value of conversion option derivative and a gain on deconsolidation of the M8 Group recognised for the three months ended 31 March 2010.
